## ORDINANCE NO. 234

AN ORDINANCE OF THE COUNTY OF SANTA CLARA, STATE OF CALIFORNIA, AMENDING ORDINANCE NO. 120 OF SAID COUNTY, WHICH ORDINANCE IS KNOWN AS THE ZONING ORDINANCE OF THE COUNTY OF SANTA CLARA, AND WAS PASSED AND ADOPTED BY THE BOARD OF SUPERVISORS OF SAID COUNTY ON THE 25TH DAY OF AUGUST A DECEMBER OF SAID COUNTY ON THE 25TH DAY OF AUGUST, A.D., 1937 BY ADDING THERETO SECTION 9-t AND SECTIONS 10 az AND 10 ba. 4 The Board of Supervisors of the County of Santa Clara, State of California, do ordain as follows: 5 SECTION 1. 6 Ordinance No. 120 of the County of Santa Clara, State of California, which ordinance is known as the ZoningOrdinance of the County of Santa Clara, and was passed and adopted by the Board of Supervisors of said county on the 25th day of August, A.D. 1937 is hereby amended by the addition of a new section thereto, to be designated Section 9-t, which consists of an index map to certain districts maps which show the Twenty-Second Unit of the Zoning Plan, Santa Clara County, California, which map is hereby incorporated and made a part of this ordinance. 11 SECTION 2. 12 Said ordinance is hereby further amended by the addition thereto of certain new sections, to be designated Sections 10 az and 10 ba which consist of a map entitled, "Sectional Districts Map, being 13 14 the Twenty-Second Unit of the Zoning Plan, Santa Clara County, California, " which map is hereby incorporated and made a part of 15 this ordinance. 16 SECTION 3. 17 This ordinance shall take effect and be in force thirty (30) days after the date of its passage and approval. 18 Passed and adopted by the Board of Supervisors of the County 19 of Santa Clara, State of California, on the 19thday of Nov. 1945 by the following roll call vote: 20 Supervisors: Brown, Pfeifle, McKinnon, Wool, Cooley AYES: 21 NOES: Supervisors: None 22 ABSENT: Supervisors: None 23 24 25 the Board of Supervisors, Chairman of Santa Clara County, California. 26 27 ALBERT J.
