PARCEL A

Beginning at a point in the Northeasterly line of Canoas Garden Avenue, 53 feet wide, distant thereon South 44° 00' 35" East. 107.25 feet from the point of intersection thereof with the Northwesterly line of Lot 7 as said Lot 7 and said Northeasterly line of Canoas Garden Avenue, 53 feet wide, are designated on that certain map entitled, 'Map of the Canoas Garden Tract," which map was filed for record on February 19, 1912, in Map Book "N" at page 85, Records of Santa Clara County, California; thence from said point of beginning running along a curve to the left from a tangent which bears North 45° 59' 25" East, through an angle of 56° 59' 15" with a radius of 156.59 feet for a distance of 155.75 feet to a point; thence North 10° 59' 50" West, 42.21 feet to a point in the aforesaid Northwesterly line of said Lot 7, distant thereon North 46° 12' 00" East, 174.30 feet from the most Westerly corner of said Lot 7; thence running along said Northwesterly line South 46° 12' 00" West, 174.30 feet to the most Westerly corner of said Lot 7; thence leaving said Northwesterly line and running along the Southwesterly line of said Lot 7 South 44° 00' 35" East, 107.33 feet to a point distant South 45° 59' 25" West, 20.00 feet from the point of beginning; thence running North 45° 59' 25" West, 20.00 feet to the point of beginning.

Being a portion of Lot 7 of the aferesaid Canoas Garden Tract, and containing approximately 0.268 acres of land, when excluding there from the portion in the present road.

Being a portion of Lots 7, 8, 9 and 10 of the aforesaid Canoas

Garden Tract, and containing approximately 17.177 acres of land when excluding therefrom that portion thereof described in the above exception.
