





# RECOMMENDED ACTION:

Authorize the chairperson to execute the agreement between A-M Company and the County of Santa Clara for the installation and maintenance of landscape improvements on Almaden Expressway and Old Almaden Road.

On a typical section of County expressway where access is restricted, the County is responsible for the installation of landscaping and maintenance of the landscaped areas. This landscape agreement, which is on the County's standard form, permits A-M Company to landscape and maintain the area shown on the Exhibit "A" attached to the agreement. A-M Company will assume liability for injury, death, loss, accident or damage to any persons or property arising out of the use of this area for landscaping purposes.
