

RESOLUTION MAKING PROVISIONS OF THE
VEHICLE CODE APPLICABLE TO PRIVATE ROADS
IN ALDERCROFT HEIGHTS KNOWN AS ROARING
WATER WAY, OLD MINE ROAD AND OAK COURT

WHEREAS, the Board of Supervisors of the County of Santa Clara, State of California, acting in accordance with Vehicle Code section 21107.5, has held a duly noticed hearing to determine whether or not the following private roads in the Aldercroft Heights area should be subject to the provisions of the Vehicle Code: Roaring Water Way, Old Mine Road and Oak Court; and

WHEREAS, this board finds and declares Roaring Water Way, Old Mine Road and Oak Court are located within a residence district and so connect with highways that the public cannot determine that they are not highways.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Santa Clara that Roaring Water Way, Old Mine Road and Oak Court be subject to the provisions of the Vehicle Code.

BE IT FURTHER RESOLVED that the Director of Public Works is directed to post at the entrances to the aforementioned roads a sign indicating they are subject to the Vehicle Code but are not county maintained roads.

BE IT FURTHER RESOLVED that this resolution shall not be effective until signs are posted in accordance with this resolution and no signs shall be posted until the owners of the private roads pay to the Department of Public Works the costs of such signs and the cost of their installation.

This refers to Board of Supervisors' approval, on June 14, 1972, of petition of residents of Locust, Laurel, Panorama and Airport Roads, Aldercroft Heights, that provisions of the Vehicle Code be made applicable to these private roads.

For the reasons set forth in Mrs. Frances Harpole's letter of May 23, 1972, residents of two additional private roads in Aldercroft Heights, namely: Roaring Water Way and Old Mine Road (including Oak Court) have signed petitions requesting that the provisions of the Vehicle Code be made applicable to these roads, also. These petitions are attached, as well as map showing the roads referred to.


Dear Mr. Sanchez:

In keeping with Mrs. Birl (H.A.) Talley's phone call to you two or three weeks ago, we are enclosing a petition of some three pages signed by the residents of Roads -- Locust, Laurel, Panorama and Airport. Attached is also a map of this part of Aldercroft Heights and a list of the property owners.

After speaking with you, Mrs. Talley contacted the Department of Public Works, as you suggested, and Mr. R. M. Shields wrote her to assemble these enclosures, submit them to you and the general Board of Supervisors with the request that these roads in Aldercroft Heights be placed under the California Vehicle Code.

In view of the literal invasion of our roads by young motorbike riders (only a few of our own) -- some from San Jose, some from other parts of the mountains --- plus some car drivers who almost "fly" these tortuous, narrow roads -- one lane -- we need the help of law enforcement, hopefully before someone is killed or maimed. Our added hope is that we might also suffer less vandalism of property and vehicles. As we sit, we have no recourse, not even to the District Attorney or the Sheriff's Deputies. Please!!
