

ORDINANCE NO. 234

1 AN ORDINANCE OF THE COUNTY OF SANTA CLARA, STATE OF CALIFORNIA,
2 AMENDING ORDINANCE NO. 120 OF SAID COUNTY, WHICH ORDINANCE IS
3 KNOWN AS THE ZONING ORDINANCE OF THE COUNTY OF SANTA CLARA, AND
4 WAS PASSED AND ADOPTED BY THE BOARD OF SUPERVISORS OF SAID COUNTY
5 ON THE 25TH DAY OF AUGUST, A.D., 1937 BY ADDING THERETO SECTION
6 9-t AND SECTIONS 10 az AND 10 ba.

7 The Board of Supervisors of the County of Santa Clara, State of
8 California, do ordain as follows:

9 SECTION 1.

10 Ordinance No. 120 of the County of Santa Clara, State of California,
11 which ordinance is known as the Zoning Ordinance of the County of
12 Santa Clara, and was passed and adopted by the Board of Supervisors
13 of said county on the 25th day of August, A.D. 1937 is hereby
14 amended by the addition of a new section thereto, to be designated
15 Section 9-t, which consists of an index map to certain districts
16 maps which show the Twenty-Second Unit of the Zoning Plan, Santa
17 Clara County, California, which map is hereby incorporated and
18 made a part of this ordinance.

19 SECTION 2.

20 Said ordinance is hereby further amended by the addition thereto
21 of certain new sections, to be designated Sections 10 az and 10 ba
22 which consist of a map entitled, "Sectional Districts Map, being
23 the Twenty-Second Unit of the Zoning Plan, Santa Clara County,
24 California," which map is hereby incorporated and made a part of
25 this ordinance.

26 SECTION 3.

27 This ordinance shall take effect and be in force thirty (30) days
28 after the date of its passage and approval.
