

AN ORDINANCE AMENDING SANTA CLARA COUNTY ORDINANCE NO. NS-5.90 RELATING TO THE COMPENSATION OF EMPLOYEES AND DECLARING THE URGENCY THEREOF, TO TAKE EFFECT IMMEDIATELY

The Board of Supervisors of the County of Santa Clara, State of California, does ordain as follows:
