ORDINANCE NO. 594 NS-1007.49

AN ORDINANCE DESIGNATING CERTAIN INTERSECTIONS OF PUBLIC HIGHWAYS IN UNINCORPORATED TERRITORY IN THE COUNTY OF SANTA CLARA, AS INTERSECTIONS WHERE VEHICLES ARE REQUIRED TO STOP BEFORE ENTERING, AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF.

The Board of Supervisors of the County of Santa Clara, State of California, do ordain as follows:

Section 1: The following described intersections of the hereinafter mentioned public highways in the unincorporated territory of the County of Santa Clara, State of California, are hereby designated as intersections of public highways where all vehicles are required to be stopped as hereinafter set forth before entering said intersections:

- 1. The intersection of CLAYTON ROAD and MT. HAMILTON ROAD.

All vehicles entering said intersection from Clayton Road shall come to a stop before entering said intersection.

An appropriate stop sign, duly authorized by law, shall be placed and erected on the southeast corner of said intersection.

- 2. The intersection of DEMPSEY ROAD and CALAVERAS ROAD.

All vehicles entering said intersection from Dempsey Road shall come to a stop before entering said intersection.

An appropriate stop sign, duly authorized by law, shall be placed and erected on the southeast corner of said intersection.

- 3. The intersection of CROTHERS ROAD and ALUM ROCK AVENUE.

All vehicles entering said intersection from Crothers Road shall come to a stop before entering said intersection.

An appropriate stop sign, duly authorized by law, shall be placed and erected on the northeast corner of said intersection.

The intersection of KENNEDY ROAD and FERRIS AVENUE.

All vehicles entering said intersection from Kennedy Road shall come to a stop before entering said intersection.

An appropriate stop sign, duly authorized by law, shall be placed and erected on the northwest corner of said intersection.

5. The intersection of BERRY AVENUE and MIRAMONTE AVENUE.

All vehicles entering said intersection from Berry Avenue shall come to a stop before entering said intersection.

An appropriate stop sign, duly authorized by law, shall be placed and erected on the southwest corner of said intersection.

6. The intersection of EMERSON AVENUE and MIRAMONTE AVENUE.

All vehicles entering said intersection from Emerson Avenue shall come to a stop before entering said intersection.

An appropriate stop sign, duly authorized by law, shall be placed and erected on the southwest corner of said intersection.

7. The intersection of EMERSON AVENUE and SPRINGER ROAD.

All vehicles entering said intersection from Emerson Avenue shall come to a stop before entering said intersection.

An appropriate stop sign, duly authorized by law, shall be placed and erected on the southwest and northeast corners of said intersection.

8. The intersection of MAGDALENA AVENUE and FREMONT AVENUE.

All vehicles entering said intersection from Magdalena Avenue shall come to a stop before entering said intersection.

An appropriate stop sign, duly authorized by law, shall be placed and erected on the southeast corner of said intersection.

9. The intersection of FAIRWAY DRIVE and MCKEE ROAD.

All vehicles entering said intersection from Fairway Drive shall come to a stop before entering said intersection.

An appropriate stop sign, duly authorized by law, shall be placed and erected on the northwest corner of said intersection.

10. The intersection of Page Mill Road and Junipero Serra.

All vehicles entering said intersection from any direction shall come to a stop before entering said intersection.

An appropriate stop sign, duly authorized by law, shall be placed and erected on the four corners of said intersection.
