SECTION 1.

So much of Ordinance No. NS-1200.10 aj of the County of Santa Clara, State of California, as establishes R-E-B-4, ~~and xxxxxxxxxxxx~~ District(s) as the zoning regulation(s) for property described in Exhibit "A" attached hereto, and made a part hereof by reference, is hereby repealed.

"A" District is hereby adopted as the zoning regulation for property described in Exhibit "A" attached hereto.

This Ordinance shall take effect and be in full force on and after thirty (30) days from the date of its passage hereof, and before the expiration of fifteen (15) days from the date of its passage, it shall be published once with the names of the members of the Board of Supervisors voting for and against the same, said publication to be made in a newspaper of general circulation published in the County of Santa Clara.



Fruitvale Avenue Area



Novakovitch; thence northerly along said line and the westerly line of the lands of N. & C. Ljepava to the center line of Wildcat Creek, thence easterly and northerly along said center line to the northerly line of the land of Walter Seagraves, thence easterly along said line to the point of beginning.
