AMENDMENT TO EXPRESSWAY AND COST SHARING  
AGREEMENT - CENTRAL EXPRESSWAY - CITY OF  
SUNNYVALE

WHEREAS, the City of Sunnyvale, hereinafter called "City, and the County of Santa Clara, hereinafter called "County", did on the 25th day of April 1966, enter into an agreement covering the cost of construction of Central Expressway; and

WHEREAS, the City has indicated that it will, in the future, desire to construct and maintain overcrossings of the Central Expressway;

NOW, THEREFORE, the aforesaid agreement is amended by adding thereto the following:

"Upon submission to the County by the City of plans and specifications covering the construction of an overcrossing, or overcrossings, of the aforesaid Central Expressway between Bernardo Avenue and a point 1200 feet east of Commercial Street, and upon the review of the adequacy of said plans and specifications as to their provision for the uninterrupted flow of traffic on the aforesaid Central Expressway, both during construction and upon completion of construction

AMENDMENT TO AGREEMENT  
BETWEEN COUNTY AND CITY RELATIVE  
TO SHARING OF COSTS FOR CENTRAL EXPRESSWAY

#5  
The following is an amendment to the agreement between the County of Santa Clara, hereinafter referred to as "County", and the City of Sunnyvale, hereinafter referred to as "City", for sharing of costs for construction of Central Expressway dated April 25, 1966.

WHEREAS, the City requests that the Wolfe Road undercrossing of the Central Expressway be widened from 4 lanes, as previously agreed upon, to 6 lanes; and

WHEREAS, County is willing to modify its construction plans to accommodate this request.

IT IS HEREBY agreed by the County and City that the agreement of April 25, 1966 above-mentioned be amended to widen from 4 lanes to 6 lanes the Wolfe Road undercrossing of Central Expressway subject to the following terms and conditions:

1. County shall make the necessary modification on the construction plans on the above-mentioned crossings.

2. In addition to the sum of \$3,100,000.00 which the City agreed to pay the County, the City shall bear the full cost of accomplishing the requested change of design, acquisition and construction. In particular, the City shall pay for:

a. All cost in making the modifications necessary to the construction plans.

b. The additional construction cost involved in constructing a longer structure spanning a 6 lane road instead of a 4 lane road at Wolfe Road and in constructing Wolfe Road as a 6 lane road instead of a 4 lane road.

c. Additional right-of-way required due to the modifications made at the above-mentioned crossing.

3. a. Compensation for modification to construction plans shall be made on a time and material basis according to the

agreement between Mark Thomas and Company, Inc., and the Board of Supervisors of the County dated November 1, 1965.

b. It is estimated that the cost of accomplishing these modifications to the plans, construction of additional facilities and acquisition of additional right-of-way is \$60,000.00. This amount is to be paid to the County within 30 days after approval of the plans by City, but in no event later than 30 days prior to advertising for bids for construction of the project. In the event the actual cost is greater or lesser than that estimated, an adjustment shall be made to provide additional payment by the City to County or refund to the City by County, whichever may be necessary under the procedure indicated in subparagraph (a) hereof.

4. Additional construction cost shall be based on the bid prices of the contract items involved in the widening of the construction over Wolfe Road and the widening of Wolfe Road from 4 to 6 lanes.

5. Evidence of all additional items of expense shall be forwarded by County to City upon presentation of claim for compensation pursuant to the Agreement of April 25, 1966, and this amendment thereto.

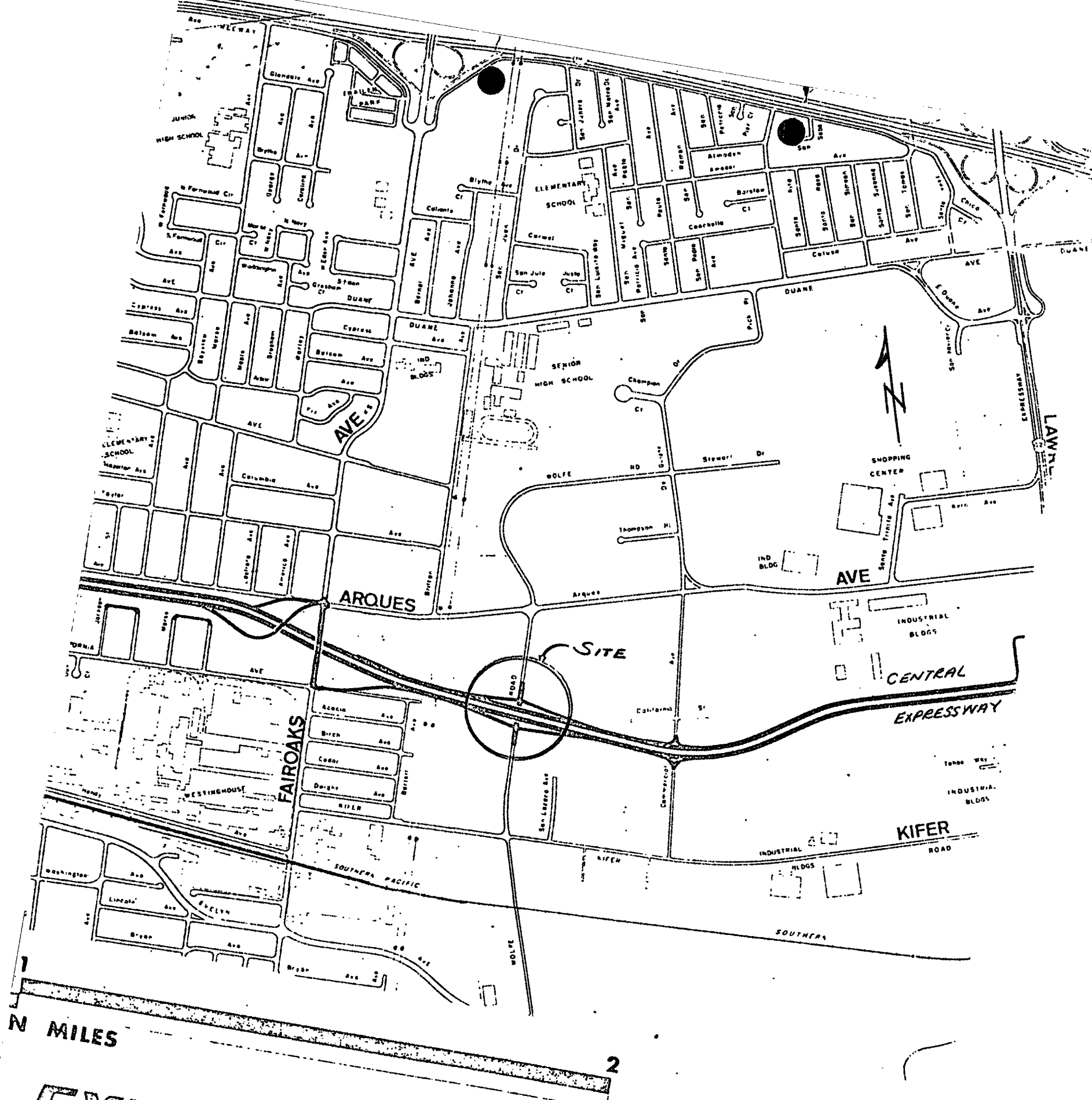

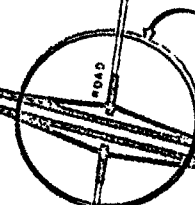

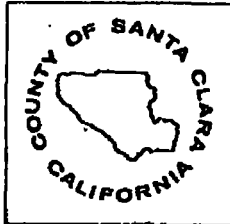

COST SHARING AGREEMENT BETWEEN COUNTY OF  
SANTA CLARA AND CITY OF SUNNYVALE FOR  
CONSTRUCTION OF CENTRAL EXPRESSWAY

THIS IS AN AGREEMENT between the County of Santa Clara (County) and the City of Sunnyvale (City) for the construction of Central Expressway between Bernardo Avenue and 1200 feet east of Commercial Street.

WHEREAS, County has adopted a resolution dated October 18, 1965 determining that a county highway be established between Bernardo Avenue and 1200 feet east of Commercial Street (herein called "the project") within City to be constructed as a portion of the Central Expressway, and City by resolution has consented to the establishment of said highway as a county highway; and

WHEREAS, the \$70,000,000 county bond issue approved by the voters on March 28, 1961 provides funds for the construction of the Central Expressway with at grade intersections; and

WHEREAS, City has requested and County is willing to include grade separation structures and connections to city streets as a part of the construction of Central Expressway within the limits of City between Bernardo Avenue and 1200 feet east of Commercial Street.

NOW, THEREFORE, City and County agree as follows:

1. PLANS AND SPECIFICATIONS

County shall prepare construction details, specifications, and contract documents for the construction of the project. County shall deliver to City one complete set of construction details, specifications and contract documents for approval by City. Upon approval by City or the elapse of thirty (30) days after delivery of the documents to City, whichever is less, County shall take all steps necessary to complete acquisition

of right of way, advertise for bids and award a contract for the construction of the project.

2. ACQUISITION OF RIGHTS OF WAY

County shall acquire all property and all rights of way necessary for the construction of the project.

3. PAYMENT

City shall pay to County the sum of Three Million One Hundred Thousand Dollars (\$3,100,000). This sum shall be the full payment for City's share of the costs of the project. Payment shall be made to County within thirty (30) days after approval of the plans by City but in no event later than thirty (30) days prior to advertising for bids for construction of the project. County shall pay the balance of the cost of the project over and above City's payment.

4. REIMBURSEMENT

It is hereby agreed that the portion of the project, paid for by City, which provides benefits consistent with the ultimate trafficways plan will cost Two Million Four Hundred Seventy Thousand Dollars (\$2,470,000). Said amount shall become available to the City as provided for in the Reimbursement Policy amendment #14 to the Expressway Policy Resolution dated December 27, 1960 attached hereto and made a part hereof.

5. INSURANCE

County shall require any contractor awarded the contract for the construction and improvement of the project to take out and maintain at all times during construction public liability and property damage insurance in a form and limits of liability acceptable to City and County, insuring City and County and their respective officers and employees from and
