**RESOLUTION OF THE BOARD OF SUPERVISORS
OF THE COUNTY OF SANTA CLARA
ESTABLISHING FEES RELATING TO LOBBYIST REGISTRY**

WHEREAS, section A3-65(a) of Division 3 of Chapter VII of the County of Santa Clara Ordinance Code authorizes the Board of Supervisors to establish by resolution fees and interest relating to lobbyist registration, annual registration renewal, and late fees for past due registration, renewal, and quarterly lobbyist activity reporting; and,

WHEREAS, the County of Santa Clara does not presently have established fees for lobbyist registration, annual registration renewal, and late fees for past due registration, renewal, and quarterly lobbyist activity reporting; and,

WHEREAS, the Board of Supervisors wishes to establish fees for lobbyist registration, annual registration renewal, and late fees for past due registration, renewal, and quarterly lobbyist activity reporting; and,

WHEREAS, under Proposition 26, such fees may not exceed the reasonable costs of performing investigations and enforcing the statute (California Constitution, Article 13C, section 1); and,

WHEREAS, the Clerk of the Board of Supervisors has proposed a fee schedule in a reasonable amount that is applied in a uniform manner.





Annual Registration Fee	60.00
Prorated Initial Registration Fee (Initial registration fee filed June 30-December 31)	90.00
Penalty for Delinquent Filing of Annual Registration Form	60.00 per Calendar Day not to exceed 100% of unpaid fee)
Penalty for Delinquent Filing of Quarterly Reporting Form	10.00
