ORDINANCE NO. NS- 300.213

AN ORDINANCE TO AMEND SECTIONS A20-41 AND
A20-42 OF THE SANTA CLARA COUNTY ORDINANCE
CODE RELATING TO THE DRUG ABUSE COORDINATION
COMMISSION

The Board of Supervisors of the County of Santa Clara do ordain
as follows:

SECTION 1

Section A20-41 of the Santa Clara County Ordinance Code is
amended to read:

Sec. A20-41. Duties

The following shall be the duties of the commission:

- (a) Establish policy guidelines for the drug abuse coordination program.
- (b) Identify drug abuse problems and needs in the county, support and assist programs and projects proposed by public and private entities to help resolve such problems and needs.
- (c) Assist in the preparation of an annual comprehensive countywide drug abuse coordination plan and also in the preparation of other countywide plans as they relate to the drug abuse problem.
- (d) Review and make recommendations on applications submitted by public and private agencies for local, state and federal funding of drug abuse programs in accordance with priorities established for the county's drug abuse coordination program, and develop cooperative relationships with other reviewing agencies.
- (e) Establish policy guidelines and procedures for the evaluation of drug abuse programs.
- (f) Form task forces or committees to assist in planning, policy, goal and priority recommendations and such other functions as the commission deems necessary; the membership shall provide for the broadest possible community participation within the specific area of the task force's assignment, shall include directors of drug abuse programs, and shall include at least one commission member.
- (g) Advise the board of supervisors on matters relating to the drug abuse problem in the county.
- (h) Serve as the technical advisory committee on drug abuse to the mental health advisory board pursuant to the terms of Welfare and Institutions Code, Section 5606.5.

Sec. A20-42. Meetings


